## SHELTER RENAMED

The shelter on Peter's Mountain, known as the Earl Shaffer Shelter, has been renamed THE PETER'S MOUNTAIN SHELTER.

It had been named after Earl Shaffer, a member and co-founder of this Club, and the first person to hike the length of the Appalachian Trail back in 1948. And, further, Earl was the first to hike it in both directions!

Over the years, improvements and modifications were made to this Shelter, which made it fancier than Earl approves of, so he requested that his name be removed from the Shelter.

The Club heard of Earl's request at the July Board Meeting, and, considering it a reasonable request, as the shelter is no longer in keeping with Earl's rugged character, regretfully complied.

The name chosen was PETER'S MOUNTAIN SHELTER, and from now on it will be so referred to in all literature and communications.

## WALKING WITH SPRING

Earl Shaffer has published a book, dealing with his first trip over the Trail. We haven't seen it yet, but the reports from those who have read it indicate that it is excellent.

The Title is "WALKING WITH SPRING ON THE APPALACHIAN TRAIL" It was privately printed. Several members have the book, and some of the other members might enjoy reading it.

Perhaps Earl could advise us how we can obtain copies.

## KING'S GAP CIRCLE HIKE

The King's Gap Circle Hike, September 25, 1983, will be a moderately paced eight mile hike through very scenic areas. There will be several significant climbs and descents, so participants are advised to carry water.

## COAL REGION RAMBLE

The Coal Region Ramble, scheduled for October 22, 1983, will be lead by Henry Knauber, of the Lebanon Hiking Club. Henry's knowledge of the coal region is legendary, and has caused him to be known as the "Wisconisco Wanderer."

The ramble will take us through abandoned coal strippings, to a deep shaft mine, to a working coal mine [The Buck Mountain Drift], and to the Swatara Falls, which is the headwaters of the Swatara Creek. This is the same Swatara Creek which gives its name to Swatara Gap, and which flows through Lebanon and Dauphin County as it empties into the Susquehanna River. And, of course, also scheduled is a traditional ice cream break in downtown Tremont.

## SUSQUEHANNA VALLEY A.Y.H. CLUB

A local American Youth Hostel [AYH] Club is being formed in Central Pennsylvania. The SATC Board of Directors has voted to join the SUSQUEHANNA VALLEY AMERICAN YOUTH HOSTEL [AYH] Club, with the understanding that other outdoor clubs would also join the AYH Club in promoting interaction between members of outdoor clubs operating in the Susquehanna Valley Area; and, further, that the AYH Club would sponsor additional programs that will facilitate the goals of member clubs. THE AGE LIMIT FOR AYH, IS ANYONE WHO IS YOUNG IN SPIRIT.

The AYH Club seeks to promote travel and understanding among people; promote recreation through self-propelled skills (i.e. hiking, biking, skiing, horseback riding, canoeing, etc.); and provides unique travel using low cost Hostels Internationally; and to publish relevant materials; and to coordinate public opinion information on important recreational issues.

Additional services provided are: group passes to SATC members, permitting accommodations for up to 25 individuals in Hostels worldwide; Social programs and special events incorporating the expertise of members.

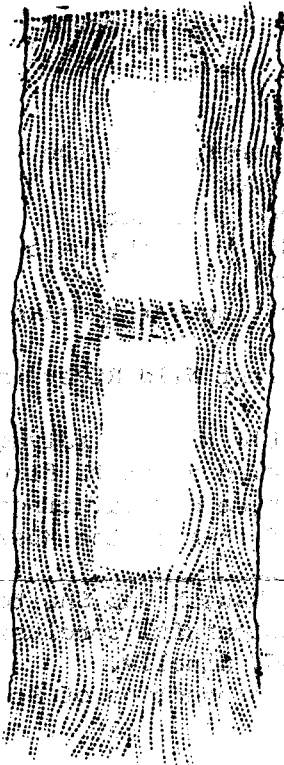
The particular reason for forming the AYH Club at this time is to undertake the operation of a hostel at Pine Grove Furnace. This would be the recently renovated Ironmaster's Mansion at Pine Grove Furnace State Park, which has been opened as the seventh youth hostel in Pennsylvania State Parks.

The mansion is located next to the Appalachian Trail, General Store, and stables, in the Park. [This section of the Appalachian Trail had previously lacked hot shower facilities in excess of two days hiking distance in both directions.] The mansion can house 46 guests in four bunk rooms. Built in the late 1700's, this show place hostel has been completely renovated. A modern commercial kitchen, spacious recreation areas, period wallpaper, glass doorknobs, and even handicapped bathrooms are but a fraction of what the visitor will experience at the Ironmaster's Mansion Youth Hostel.

Cost of the use of the Pine Grove facility is \$5.25 per night for AYH members; \$7.25 for non-members, between March 1st and September 30th. From October 1st through February 28th [29th on leap years] there will be an additional \$1.00 per night charge. Also, there is a \$1.00 charge per stay for a clean bed roll.

# TRAIL BLAZES No. 1

I have been requested to give a few short articles dealing with the early history of the club. This I will attempt to do in this column.

## WHY TRAIL BLAZES?

Many of you may wonder at my choice of a name for this column. I chose "TRAIL BLAZES" with the double blaze symbol -- because, when this Club was first founded, and joined the Appalachian Trail Conference, Jean Stephenson explained the Trail Markings to us:

As she explained, "The double blaze means an alert - it is trying to call our attention to something! 99 times out of a hundred, it is a turn in the Trail."

~~Now this column is that one out of hundred that is, simply,~~ trying to call your attention to something. Hence the name.

## THE FIRST APPALACHIAN TRAIL CLUB IN HARRISBURG

We are apt to think of the Susquehanna Appalachian Trail Club as the first Trail Club in Harrisburg.

Not so! Long before we organized the Susquehanna Appalachian Trail Club, and even before there was an Appalachian Trail, there was an active Hiking Club in Harrisburg--and it was just as active as the Susquehanna Appalachian Trail Club is today.

That Club was the Pennsylvania Alpine Club--with chapters in Harrisburg, Chambersburg, Dushore and other cities. And, it constructed and maintained its own series of Trails. Perhaps the best known was the Darlington Trail.

The Darlington Trail started at Overview, just off the West end of the Rockville Bridge and ran to the Kings Trail, just west of Chambersburg. It was named for the beloved Secretary of the Pennsylvania Alpine Club.

That Secretary was Bishop Darlington, DD, who was the minister at St. Stephens Episcopal Cathedral in Harrisburg.

Not only was the Trail named for Bishop Darlington, but a monument was erected to honor him on the Mountain at the East end of the Rockville Bridge. That Monument has since been destroyed by vandals.

You may ask how the Pennsylvania Alpine Club fit into the Appalachian Trail picture. And, the answer is that it was one of the original A.T. clubs. And, it was the desire of the Pennsylvania Alpine Club that its Darlington Trail be incorporated in the Appalachian Trail, with the Darlington extended down Blue Mountain to Hancock, Md.

When the South Mountain route was chosen over Blue Mountain, the Pennsylvania Alpine Club lost interest and dropped out of the Appalachian Trail Conference. This left a void in the Appalachian Trail, which had to be picked up by other clubs. Only that portion of the Darlington Trail from Overview to Lambs Gap became part of the Appalachian Trail.

[This information was related to me by Colonel Shumaker, who was State Historian as well as the last President of the Pennsylvania Alpine Club.]

## THE STONY VALLEY COALITION

### THE STONY VALLEY COALITION HAS DISBANDED!!

The SATC was a member of that Coalition right from the start, and can be proud of the achievements of the Coalition, and its part in those achievements.

What was accomplished?

The Coalition succeeded in making PP+L withdraw one misleading pamphlet on the Dam project--which indicated that sportsmen would be able to use the lower dam.

The Coalition succeeded in having one PP+L Rate Increased reduced somewhat.

The Coalition was able to establish that the water quality of Stony Creek, below the Dam could not be maintained--because of the turbulence of the water.

The Coalition, working through its member groups, furnished the manpower to make the survey, that eventually led to Wild River Status.

The Coalition was able to have Stony Creek established as the first Wild River in the Commonwealth.

The Coalition, through its Stony Creek Wild River efforts, was able to help salvage the Commonwealth's Wild and Scenic River Program, when that program seemed about to flounder.

The Coalition, through one of its members, was able to locate three old paintings of Cold Spring and Rausch Gap, purchased them for \$600.00, and donated them to the Museum of the Lebanon County Historical Society.

The Coalition was able to give \$100.00 toward renovation of the Rausch Gap Shelter.

The Coalition was able to bring the Stony Valley Problem to a successful conclusion, with the land turned back to the Pennsylvania Game Commission, and, finally,

The Coalition was able to set aside \$20,000, to be used for the protection of Stony Valley for the next ten years.

The income from that \$20,000 will be disbursed through the Central Pennsylvania Conservancy, with first choice going to help projects in Stony Creek Wild River Corridor.

Thanks, for letting me represent you on the Coalition's Board.
